THE CLEANING OF THE PREMISES UP DEPARTURE IS INCLUDED IN THE RATE. HOWEVER, THE KITCHEN MUST BE LEFT IN THE SAME CLEAN CONDITION AS WHEN CHECKING IN, OR THERE IS A EXTRA CLEANING FEE OF \$100 . ONLY THE AGREED UPON GUESTS ARE PERMITTED. IF AT ANY TIME OTHER GUESTS ARE PRESENT, TENENTS SHALL BE OBLIGED TO LEAVE THE PROPERTY AND FORFEIT ALL MONIES.**

**HOLD HARMLESS AND WAIVER: TENANT'S SHALL INDEMNIFY AND HOLD HARMELSS THE OWNER FROM AND AGAINST ANY AND ALL CLAIMS ARISING FROM THE TENANTS USE OF THE PREMISES AND ANY AND ALL AMENITIES ON THE PROPERTY AVAILABLE TO TENANT'S, INCLUDING DAMAGES, COSTS, ATTORNEY FEE'S, EXPENSES AND LIABILITIES INCURRED IN THE DEFENSE OF ANY CLAIM OR ACTION PROCEEDINGS ARISING THERE FROM. TENANTS HEREBY ASSUME ALL RISK OF DAMAGE TO PROPERTY, FURNITURE ETC. OR INJURY TO PERSON'S IN OR ABOUT THE PREMISES FROM ANY CAUSE OR PERSON OR ANIMALS.**
